**GRAVE OPENING & CLOSING AUTHORIZATION 2023**

Effective December 1, 2003 Adath Cemetery requires payment in full prior to interment of all lot fees to include grave purchase cost of the deceased grave, opening & closing, & perpetual lawn care and any fees currently due from previous interments on double grave. If the deceased is interred in a lot with a single/double flower box, and *perpetual flower care has not previously been paid, flower care will be due with lot fees.*

**Accepted forms of payment in full prior to interment are as follows;**

- Credit Cards, Visa & Master Card
- Personal Checks or check from funeral provider
- Pre-need insurance policy with irrevocable assignment of benefit to Adath Yeshurun Cemetery or an insurance policy assignment of benefit, to entitle Adath Yeshurun Cemetery to receive benefits. Insurance assignments must be on file at the cemetery prior to interment.

- **Hennepin County assistance cases:** Family must follow current published guidelines set up by Hennepin County. *Benefit is contingent to the approval by the county.* Current county funeral benefit of \$3400.00 will be paid directly to the funeral home. Funeral home will submit the application of benefit to Hennepin County. Upon acceptance the family will be asked to contribute an additional \$1600.00 which will be used for additional funeral related expenses (cemetery), including cemetery plot, opening closing grave & perpetual lawn care. Total funeral expenses can't exceed \$5000.00. If no grave is owned prior to death the cemetery will provide a grave (*flat marker area only located in Section SHO2 Block 1*). Above cost does not include a marker. Cemetery does require grave marked. If application is denied by Hennepin County please refer to current published cemetery general price list.
- Prior to interment, cases of hardship must be discussed with the cemetery manager and they will be reviewed by Cemetery Manager and/or the board of the cemetery on an individual basis.
